



ABO News and Information

The most recent Scenario-based Clinical Examination was administered through the Pearson Vue worldwide testing centers in October. The results of that exam are currently pending. The next and **ONLY** Clinical Examination for 2023 will be given on February 22-24. Registration for that exam is now closed. The Written Examination in 2023 will administered on April 4th. Registration for the written exam closes on January 12, 2023. Please see the ABO website for more details regarding the examination process.



AAO PAC

Since the annual session there have been two significant developments. The first is an extension of what I reported at that meeting. Changes in the by laws now permit the PAC to contribute at the state level. At a recent ad hoc COGA/PAC meeting in St. Louis, steps were taken to reorganize our advocacy efforts with an emphasis on state engagement. I expect this will be covered in COGA report.

Although PAC dollars were not used in this case, it is an example of state advocacy that the AAO contributed \$20,000 from the Legal Support Fund to support Issue 2 in Massachusetts. This issue requires dental insurers to submit medical loss ratios to state regulators and to refund excess premiums to customers if the annual medical loss ratio is less than 83%. The loss ratio measures the amount spent on dental expenses and quality improvements. The issue passed decisively.

AAO and MAO Work Together through Grassroots Effort to Address Workforce Shortage Issues

On October 14, the Michigan Board of Dentistry approved proposed rule changes that would allow unregistered dental assistants to perform certain orthodontic tasks under direct supervision. Since unregistered dental assistants have a shorter pathway to become eligible to work in a dental office, allowing dental assistants, with the required training, to perform certain orthodontic tasks under direct supervision is not only practical, but it is one solution to help address the workforce issues Michigan orthodontists are facing.

The Michigan Board of Dentistry actively proposed changes to its Dentistry General Rules this summer, which include delegable tasks to dental auxiliaries. In August, AAO along with nearly 60 Michigan Association of Orthodontists (MAO) members, led a grassroots effort to submit public comments to the Michigan Board of Dentistry to address workforce shortage challenges and recommend specific updates to the Dentistry General Rules in Michigan. Similar to orthodontists in many other states, Michigan dentists and orthodontists are feeling the effects of a shortage of workforce, and specifically, are having a difficult time finding and hiring dental assistants, and more specifically, orthodontic assistants.

"These modifications to the current Dentistry General Rules will help address workforce challenges while also enhancing access of patient care to specialty services," says Dr. Nathan Thomas, MAO President.

Special thanks to Dr. John Monticello, Dr. Nathan Thomas, Dr. Fatima Ahmed, Dr. Brandon Shoukri, MAO Executive Director Matt Solak, and MAO members for their important contributions to this advocacy priority focused on workforce issues. Grassroots advocacy outreach makes a difference, and this Michigan example demonstrates the power of AAO advocacy working with AAO members locally to help advance our policy priorities. The rules, as passed by the Board, will be revied by the Michigan Joint Commission on Administrative Rules prior to enactment.

The AAO is advocating for workforce solutions at the federal level, too. Our AAOPAC helps fuel advocacy success not only in Washington, DC but in states across the country as well. Consider sharing your support for solutions to workforce shortages now by contributing at AAOPAC.org.
