The AAO continues to be the preeminent association in all of dentistry and I am confident that Chris Roberts, our new Trustee, will represent us with the same distinction as David and Terry. Again, I am deeply grateful for your trust and ask for your support, as we prepare for the 2013 AAO Annual Session in Philadelphia.

The Board of Trustees met February 17-19, 2011 in St. Louis. Following is a brief overview of the highlights of the Board Meeting.

Council on Communications: The Board heard presentations from Athorn Clark, a New York advertising firm along with the current public relations (Weber Shandwick) and advertising (Schupp) firms regarding targeting the adult segment of the population. The Board also approved the following council recommendations: (1) New photography for braces.org to include lifetime rights and sharing with the AAO membership. (2) Qualitative and quantitative studies of general and pediatric dentists be referred to the Task Force on Relations with General Practitioners and the Public for the purpose of learning about referral patterns since the completion of the 2006 General Dentist Study. (3) The creation of all consumer education brochures in an $8 \frac{1}{2} \times 11$ format that is downloadable from AAOmembers.org. (4) Hiring the advertising firm of Athorn Clark to develop an advertising/public relations plan that would significantly increase market share for the teenage and adult markets. (5) Postponing the recommendations for both the \$650 and \$1,500 assessment motions until the Athorn Clark proposal is reviewed. (Steve Belli-GLAO representative)

Council on Education: The Board approved the following council recommendation: Revisions to the CODA Revised Standards for Advanced Specialty Education Programs in Orthodontics and Dentofacial Orthopedics. (Gene Roberts-GLAO representative)

Council on Governmental Affairs:

The Board approved the following council recommendation: Revisions to the Patton Boggs Evaluation Form. (Don Hayes-GLAO representative)



Council on Health Care: The Board approved the following council recommendation: That the HOD approve COHC's Strategic Plan Revisions. (Bob Brown-GLAO representative)

Council on Membership: The Board approved the following council recommendations: (1) That the HOD allow the AAO to communicate the content of Resolution 14-09H, especially, "In addition to other rules, in any public statements, announcements of services, and promotional activities, all claims made or utilized by members must be supported by scientifically reliable evidence." to all members; additionally, any future changes to the AAO Principles of Ethics and Code of Professional Conduct be communicated to our membership in a timely manner. (2) That the HOD adopt new policy allowing Student membership status to terminate automatically upon the completion of any one of the following, 1) election to active, affiliate or other applicable membership category; 2) on May 31st of the year immediately following successful completion of an accredited orthodontic program; or 3) upon termination of status for any other reason as a student in an accredited orthodontic program. (Richard Marcus-GLAO representative)

Council on New and Younger Members: The Board elected D. Andrew DeHaan, a resident at the University of Detroit Mercy as one of the two resident members for 2011-12. (Scott Schulz-GLAO representative)

Council on Orthodontic Practice: The Board approved the following council recommendations: (1) A brochure discussing the risks associated with ingesting acidic and sugary foods and drinks during orthodontic treatment be developed in conjunction with the Council on Communications. (2) That all Specialized Orthodontic AssistantsSM (SOA's) upon

certification receive one year's complimentary membership in the Orthodontic Staff Club. (Michael Sherman-GLAO representative)

Council on Scientific Affairs: The Board approved the following council recommendation: Monetary awards be given to the top three Table Clinics presented at the AAO Annual Session. (Nan Hatch-GLAO representative)

Board Committees: The Board approved the following board committee recommendations: (1) New policy for broadcast emails. (2) New policy for the Annual Session Review Committee. (3) That all Councils wishing to hold more than one face-toface meeting during the 2012-13 fiscal year prepare a justification for any additional meetings and submit with their budget request; additionally, all staff liaisons to councils will be responsible for communicating this requirement as well as the approximate cost of council meetings and availability of other meeting methods (i.e., conference calls, webbased meetings, video conferencing, etc.). (4) That the HOD adopt the recommended new Policy on Reserves, requesting the three most recent external public accountant audit reports for total annual unrestricted expenses instead of only using the most recent. The annual calculation would also be made using a 36 month rolling average of the liquid reserves instead of current 24 months. (5) A Reserve Fund for Building Repairs and Maintenance by budgeting an expense of \$50,000 each fiscal year to build the fund up to 10% of the fair market value. (6) That a qualified architect prepare a Building Master Plan which addresses the renovation needs of the AAO headquarters building and provides a multi-year plan to update the building, including projected budgets. (7) That the HOD adopt the best business/association practice principle of not utilizing investment income to balance the budget. The proposed plan will be to

reduce the investment income revenue line item by 25% each year over a four year period, beginning with the 2011-12 budget.

Ad Hoc Committees: The Board approved the following committee recommendations: (1) Guidelines for the Speaker of the House to consider regarding the Delegation Chairs meeting and potential scanning opportunities for the Delegates. (2) That the Board of Trustees, in consultation with the councils, study the structure of the councils related to 1) future changes in the membership and volunteer demographics; 2) potential changes in council composition related to expertise versus geographical representation; and 3) potential use of consultants and/or vendors on councils with a report to the 2012 House of Delegates. (3) That the **HOD** create a Task Force of the House of Delegates to study the geographic configuration of the AAO; consideration to include but not limited to the Governance Task Force Report. (4) That the Board of Trustees, in consultations with the councils, study the terms of council members with a report to the 2012 House of Delegates. (5) Revisions to the AAO Humanitarian Award including nominations being allowed by any AAO member to the Humanitarian Award Nomination Committee, which shall consist of the eight immediate past presidents of the AAO. The AAO Board will make the final selection and the winning candidate will also be submitted to the ADA as a nomination for the ADA Humanitarian Award. (6) The creation of 17 new videos for use on braces.org and by members. (7) Continuation of the AAO Distance Learning Project. (8) That the **HOD** adopt revisions to the AAO Bylaws, Manual of the House of Delegates, AAO Policy Manual and Standing Rules and Orders and Financial Policies. (9) Funding the Access to Care Task Force's Pilot Program to the end of the current fiscal year. CONTINUED ON PAGE 6...



Other Recommendations: The Board approved the following recommendations: (1) That AAO staff and the Council on Communications develop an online interactive communication vehicle for members to use in presenting and discussing clinical orthodontics; and that the vehicle, which will include appropriate legal safeguards, offer options to present photographs, digital radiographs and video in addition to written description and comments. (2) That the February 2011 report to the Board from the Council on New and Younger Members be referred to COOP, COC, COIT, and relevant AAO staff for review and recommendation of potential actions regarding the issues referred to CONYM from the Board. (3) That the 2012 Board Planning Session take place in Santa Fe, New Mexico, June 28-July 1, 2012. (4) Hosting a 2011 GORP picnic at the AAO headquarters. (5) That the AAO sponsor an international student reception to promote membership during the 2011 European Orthodontic Society in Istanbul, Turkey. (6) Gene Roberts was

nominated for the ADA's Norton M. Ross Award for Excellence in Clinical Research.

AAOPAC: The Board approved John Hancock and Associates be retained for an additional six months as fundraising consultant to the AAOPAC. (Rick Pfeffer-GLAO Director)

AAOIC: The Board nominated **Terry** Pracht and John Buzzatto to serve three year terms as Directors of the AAO Insurance Company.

Budget and Finance: The 2011-2012 budget proposed by the Board of Trustees includes revenues of \$15,957,393; expenses of \$16,229,787; with a projected deficit of \$272,394. Revenues were reduced by \$325,000 as a result of the 25% reduction in the investment income revenue line item. This results in a \$35 dues increase. The budget does not include an assessment, although two motions requesting a \$650 and \$1,500 assessment will be considered by the House of Delegates.

There is Risk in Allowing Patients to Dictate Treatment

In an orthodontic malpractice claim, it is not unusual for the patient or parent to have attempted to dictate treatment to the doctor. One may insist on having only the maxilla treated, another only the mandible, even if the doctor advises two-arch full treatment. Some patients refuse extractions or recommended surgery. Since orthodontics is a technical specialty, it is difficult to understand why a patient would demand a treatment not advised by the doctor. There are many reasons why this happens; some may be due to vanity others expense. Whatever the reason, if the treatment dictated by the patient is unsuccessful, it is not uncommon for the patient to

file a malpractice claim against the orthodontist despite his/her precautions. Here are a few case summaries:

Case # 1: The adult patient presented with a maxillary lateral cross bite and protruded cuspids. Her upper first bicuspids had previously been extracted. She requested treatment to correct her maxillary teeth only - for cosmetic and financial reasons. The orthodontist noted that both arches needed treatment; he nevertheless acquiesced and treated only the upper arch. He did not close the bicuspid spaces due to occlusion. The patient signed an Informed Consent

document. Her treatment lasted four months, and the bands were removed. Later she complained that her lower teeth hurt and her bite felt off. She was given a retainer which she wore for two months. After that, she complained that she had severe headaches and light sensitivity. Her medical doctors could not determine the cause of her pain. Her general dentist told her she had TMJ pain caused by negligent orthodontic treatment and she sued the orthodontist. The orthodontic experts who reviewed this case believed the treatment should have included both arches. The fact that the doctor

EDUCATION SPOTLIGHT

The University of Western Ontario

The University of Western Ontario (UWO) is located in the "Forest City" London, Ontario (population 350,000) and has a fulltime enrollment of 35,000 students. The graduate program in Orthodontics was the only UWO clinical dental specialty program until recently when the graduate program in Oral and Maxilofacial Surgery was established in 2007.

The UWO graduate orthodontics program was established in 1973 by W.S. Hunter, as a two year program with a thesis component leading to a Master of Clinical Dentistry Degree under the aegis of the School of Graduate and Postdoctoral studies. In 1994 the program was extended to 36 months. The entrance to the graduate orthodontics program is very competitive. The ratio of highly qualified applicants to resident positions is approximately 20 to 1. While top dental graduates from the two dental schools in Ontario comprise a fair proportion of those admitted to the graduate orthodontic program, successful applications have come from every Canadian Province, the United States as well as Europe, Australia, Africa, and Asia. The University of Western Ontario and its affiliated colleges offer an exceptional international student climate with rich cultural diversity, to the benefit of all graduate and undergraduate students.

The Western graduate orthodontic program commences the first week of June. The first year residents complete a very comprehensive pre-clinical technique course in biomechanics in 10weeks. During the same period they are taking and analyzing orthodontic records for their 70 assigned pediatric and adult cases. After preparation, all cases will be presented in seminar for treatment approval by the supervising clinical instructors. Clinical practice commences in September with clinical sessions on a weekly, bi-weekly or





Each clinic session is preceded by a clinical seminar. A variety of orthodontic appliances and bracket systems are used in the clinic, offering the residents a broad clinical experience. The graduate students are

monthly basis.

encouraged to use as many systems as possible. That experience will give them the perspective to pick and choose from the strengths of each system. In addition to their 70 initially assigned cases, residents gain experience from a number of transfer and retention cases as well.

The student attrition rate is zero and all residents have successfully completed their clinical assignments and defended their respective thesis within the normal duration of the graduate orthodontics program. All residents have met the requirements for fellowship in the royal College of Dentists of Canada or those who opted to write Part II of the ABO exam did so without difficulties.

Each graduate orthodontic resident at UWO must commence a research project in the winter term of the first year of their residency as a partial fulfillment for their Master in Clinical Dentistry Degree. Graduate students can select from an array of topics in areas of clinical or basic science research. Areas of interest include cranio-facial growth and development, biomechanics, dental materials, epidemiology, skeletal biology and clinical microbiology.

Council on Communications

Consumer Awareness Program (CAP) Free Consultation Coupon

The free consultation coupon program was launched February 1st and will continue until May 31st. Consumers are directed to the braces .org website where they can download a coupon for a free consultation along with a list of AAO orthodontists in their area. This voluntary program is designed to measure the effectiveness of the CAP. Experts on consumer behavior suggest that this is the most accurate way to measure the effectiveness. Members are encouraged to report redemptions monthly to the AAO. An in-depth study by Peters marketing research of select members is also being conducted.

Continuation of CAP

The 2011 House of Delegates will consider a Council resolution for a five-year assessment of \$650 per member per year to support the continuation of the AAO Consumer Awareness Program. A task force has been formed to study the manner in which the program is funded. Vs. funding of the program with possibly increasing the assessment.

Public Service Announcements

In May 2010 the AAO produced and released public service announcements to TV stations in the U.S. and Canada and radio stations in the U.S. They were released to 1,000 U.S. TV stations, 55 U.S. Cable stations, and 70 Canadian TV stations. On TV, there were over 25,000 broadcasts with an audience of over 200 million. There were over 50,000 radio broadcasts. The equivalent dollar values of the TV broadcasts alone were over three million dollars.

Outreach to Healthcare Organizations

The AAO is establishing a relationship

with the National Association of Pediatric Nurse Practitioners. The effort is intended to educate healthcare colleagues and their patients. The AAO is also reaching out to the Society for Physician Assistants in Pediatrics as well as the Hispanic Dental Association. The AAO has established a relationship with the American Academy of Pediatrics.

General Practitioner Task Force

The AAO has established a task force to explore ways to improve the AAO's relationship with general dentists in both the practice environment as well as the doctoral education program. We are considering putting together a series of lectures and DVD's that can be presented to dental students and dentists.

Online Marketing Toolkit

A section was recently added to the Online Advertising/Marketing Toolkit titled Web Content that includes a substantial list of AAO-created items that members may download for free and use on their practice Web sites. The toolkit is a catalogue showcasing the wide variety of materials to help members promote their practices. This includes print, online and radio advertising/public relations materials developed for the AAO's current "Puzzle" campaign as well as the previous "More Than A Smile" campaign. Many materials can be customized. The toolkit can be accessed after logging in to AAOinfo.org in the "My Practice" section, "Marketing" subsection.

AAO Brochures

The COC is reviewing the patient/consumer education brochures. All AAO brochures are available in PDF format for download from the "Resources" section of AAOinfo.org. They can now also be added to a

member's website. The Council is considering development of a number of new brochures including one on lasers in orthodontics.

Member and Patient Census Survey

The AAO will survey members in the first quarter of 2011 to gather information about members and the patients treated in calendar year 2010. This study is done every-other year. Members will be notified of the survey via e-mail and will be able to complete the study online. Members are encouraged to respond.

Council on Governmental Affairs

The AAO Council of Government Affairs met in Washington D.C., January 24-25th 2011. At that meeting, our legislative council Patton Boggs members, Kevin O'Neill, John Jonas and Eugenia Edwards, gave an update on legislative healthcare issues. They discussed efforts underway to repeal-in whole, or in part, the "Obama Health Care" legislation, the "Red Flags Rule" and the 1099 submission requirement (that was subsequently repealed in early February). Additional Council discussion focused on the Congressional legislative priorities of the AAO and the Congressional Leave-Behind materials that were to be distributed later that week in Capital Hill visits.

Following the President's State of the Union Address, Patton Boggs sent council members their perspective on President Obama's agenda and how it might influence orthodontic concerns over the remainder of his term in office. They believe his policies will move more towards the center with his support leaning towards those issues with broad bipartisan support, which connect with the American public and use his Executive power to implement other elements of his agenda through Executive Orders and Regulations.

The economy and the high unemployment rate will continue to be the story that directly affects orthodontic demand over the next few years. As jobs are lost in the US and created elsewhere in the world, and the dollar is threatened to lose its position as the reserve currency of the world, public confidence in longerterm financial commitments, such as orthodontic care, declines. The way the Federal government manages the increasing Federal debt and deficit spending must change. The President believes that creating jobs through green-energy initiatives, for example, may provide a way to demonstrate that good days still lie ahead, but controlling the money supply is paramount. Even despite the results of the mid-term elections, it is believed that over the next couple of years, any tax reform legislation ultimately considered by congress will, at least occur within the structure of the current income-based system, as opposed to wholesale replacement of the Tax Code with an alternative approach, such as national retail sales tax, value-added tax, or consumption tax.

Immediately following the COGA meeting, the AAO 2011 Professional Advocacy Conference began in Washington D.C. Attending from the Great Lakes region were Drs. Phillip Beckwith, Gregory Oppenhuizen and Ronald Hathaway. The meeting opened with former Speaker of the House, Newt Gingrich, speaking to the group. The Planning Committee COGA Chair, Dennis Hiller, opened the following day with welcoming remarks by AAO President Dr. Lee Graber and from our Legislative Counsel, Mr. Kevin O'Neill. Over the

coarse of the morning there were presentations by the following members of Congress: Rep. Jason Altmire(D-PA), Rep. Ron Kind(D-WI), Rep. Kevin Yoder(R-KS), Rep. Sam Graves (R-MO), Rep. Tom Price(R-GA), Rep. Paul Gosar (R-AZ), Rep. Chris Van Hollen(D-MD) and Sen. Mike Johanns(R-NE).

On Wednesday morning we had a presentation by Michael Graham, the ADA Senior Vice President for Government Affairs, preparing the Advocacy Conference attendees for the visit to their Senators and Representatives. Buses then departed for visits to Capital Hill where members met with their respective Congressmen to present the AAO's 2011 Legislative Agenda and provide informational leave-behind materials essential for our issues going forward. These efforts make a huge difference when problems or issues arise affecting our specialty. It is terribly important that we, as orthodontists, all support the AAO/PAC. It is through your generous contribution to the PAC that funding is available for the operation of the Council of Government Affairs to protect the interests of the orthodontic specialty as the debate on health care continues. Council on Membership, Ethics & Judicial Concerns

The Council met in St. Louis on January 22,2011. Here are some highlights of that Meeting and recent Council activities.

Ethics Column - The Council welcomed the efforts of our new AJO-DO editor, Dr Vince Kokich, in assigning Dr Peter Greco the task of writing a monthly column in the AJO-DO on ethics. COMEJC has set up a sub-committee to work with Dr Greco on suitable subject matter for future columns.

Application Process - COMEJC is working on the task of permitting electronic application for AAO membership. The guiding principles for this type of application will include making the electronic application consistent with the current paper application, and having the electronic application include the Principles of Ethics and Code of Professional Conduct, such that the prospective applicant must "accept" that the Principles and Code have been read and accepted.

Payment Options – In the past two years, the AAO has seen a steady increase from 500 to 1200 members taking advantage of the 3-month or 6-month payment options. The Council will be recommending an 11-month option payment option, in addition to the current 3 and 6-month options.

International Recruitment and Retention - One of the significant growth areas of the AAO is that of our International membership. In an effort to encourage greater International attendance at AAO annual meetings, the International Lounge at the Annual Session, will be upgraded.

COMEJC and CONYM Joint Meeting –The Board of Trustees directed these

The Board of Trustees directed these two Councils to consider the needs

and interests of our new "Gen Y" members. Both Councils met together to share their thoughts Amongst the issues considered, are:

- expanding the number of orthodontic programs provides the AAO an opportunity to increase its number of members
- Linked-In was reported to provide more layers of security, be more selective with members, and to have better and private discussion Boards
- more younger graduates are working in large dental groups, and the AAO will need to focus on these younger orthodontists to become members
- an AAO credit union could be helpful especially when it can assist with student loans
- the need to build trust between residents and the AAO from the date of admission of residents to ensure a lifetime commitment to the Association
- providing each new student member with an AAO e-mail address to assist in continual contact with the Residents

Transition from Student to Active Membership - COMEJC will be recommending one additional year of grace as a student member, plus the added grace time from graduation to the next June, before application to active membership. It is hoped that this will allow the AAO to keep our newly graduated members in the fold while they determine their future career options. Residents are often taking much longer to establish themselves, and this extension in grace time will help in this transition.

Reinstatement - COMEJC will be recommending that, to encourage lapsed AAO members to reinstate their membership, the current need to pay all back dues and assessments be dropped. Only a \$200 reinstatement fee would be required.

The Council on Scientific Affairs (COSA) met via videoconference on January 7, 2011.

COSA reviewed 18 applications for the Hellman, Sicher, and Graber Awards. The following are the 2011 AAO Research Awards winners:

The BOT has asked COSA to monitor research on orthodontic appliances and processes that could potentially change the doctor/patient relationship through "direct to consumer" products for orthodontic treatment, for the potential impact on the well-being of the patient. COSA members will review this directive at their meetings.

COSA continues to be involved with evidence based orthodontic research. Article citations are being added to the evidence based orthodontic research website on a regular basis. The website is found on the AAO website under the Resources tab.

COSA continues to monitor the orthodontic literature for articles to add to the Bisphosphonate website. The website is found on the AAO website under the Resources tab.

COSA's next meeting is on Friday, May 13, 2011 prior to the start of Annual Session. During Annual Session, COSA members will be involved with judging the Charley Schultz Resident Scholar Award presentations, judging the Table Clinics and awarding the Joseph E. Johnson Table Clinic Award, moderating the Oral Research presentations and moderating the lectures given by the Hellman, Sicher and Graber Award winners.

COSA meets every January by videoconference. The next videoconference meeting is scheduled for January 6, 2012.

Council on Insurance

The Council on Insurance is faced with extremely high losses in the traditional fee-for-service health insurance plan. Though this plan has traditionally been favored by Orthodontists for political and philosophical reasons, the low enrollment and high costs, conspire to push this choice out of reasonable

attainment for our Association. In the near future only 2 health plans will be available through the Association, both involving a high deductible and a more limited provider and service menu. In this method, the Association will continue to offer health insurance for those in need, but still maintain affordability within the

difficult constraints imposed by the current administrations insurance legislation fiasco. Members who are currently under prior plans will of course retain their "Grandfathered" status, and continue to enjoy the insurance they have come to rely on through the AAO.



Council on Orthodontic Education

Since the GLAO Annual Meeting at the Breakers last September, COE has had their fall face-to-face meeting in St. Louis October 25, 2010. Dr. Leslie Will from Boston University is now the Chair of COE and she has proposed two major issues for COE to address:

- American Association of **Pediatrics**: We would like to have stronger links with them, and Dr. Graber has asked us to see whether we might provide them with any information or resources that would help them realize how we might partner with them. This topic will be discussed at our COE meeting in March, but if anyone has any resources or ideas in advance of that time, please send them along because the orthodontics profession could benefit from forging strong links between our two organizations.
- Orthodontics Graduate
 Program Accreditation: Based
 on our experience in HOD
 activities last year, a number of
 dental educators indicated they
 are opposed to developing
 stronger clinical accreditation
 for graduate orthodontics
 programs. However, there
 appears to be a differing opinion

among other educators. Dr. Will sent an e-mail to all the orthodontics chairs in October inquiring about their concerns. One resounding theme was that of standards — are we opening new programs with minimal standards that might bring the quality of our profession down? Do we need tougher standards? Of course, no one seems to want tougher accreditation standards when they are being site visited, but is there some way we can move toward raising standards? Last year we proposed that students be required to prepare cases for the ABO initial certification exam, and that was turned down — perhaps in part because many directors don't want the ABO requirements driving our educational programs, but perhaps because they thought they could not be accomplished in two years. The challenge here is to attain a balance between what seems reasonable to the majority of chairs and directors and how high we can raise the standards. Current accreditation standards are so general and open to interpretation, orthodontic programs can teach as little, or as much as they like. For example, Standard 4-3.2 and 4-3.3 deal with the types of patients each student should experience. Is it reasonable to REQUIRE that each student treat a Class II patient? An

extraction patient? To both start and finish at least one patient? It is currently possible to graduate without achieving any specific clinical requirements. Is that in the interest of the orthodontics profession?

Annual Dean's Luncheon at ADEA:

Dr. Ed Yen (PCSO), Dr. Al Weimer (RMSO, and Gene Roberts (GLAO) were responsible for organizing the program. As the Chair of the organizing committee, Dr. Yen took the lead in arranging the speaker: Professor Johann de Vries, Dean of the University of Adelaide in Adelaide, Australia. The topic is "Global Dental **Education Marketplace: Survival** and Success" and the luncheon lecture will be presented Sunday, March 13, 2011 from 12:30 p.m. -2:00 p.m. at the Manchester Grand Hyatt San Diego, Room: Windsor BC. The AAO Dean's Luncheon is in conjunction with the 2011 American Dental Education Association (ADEA) Annual Session in San Diego, California. This annual lecture is an opportunity for the AAO to have a direct dialogue and interaction with the senior administrators of domestic and international dental schools.

Board Liaison Report

Council on Communications (COC) Report

Dr. Bob Brown, COHC Liaison to COC reported the following initiatives undertaken by COC:

- The free consultation coupon initiative will launch February 1, 2011; the initiative is intended to drive potential patients to participating offices
- Social networking webinars will be conducted to educate members on their use
- Marketing materials that were developed to support the consumer awareness campaign are available for member use
- The council is reviewing all brochures to determine if revisions or discontinuance are in order: topics are being reviewed with thought toward creation of new brochures.

DBAS Report **National Dental Benefits Conference** (NDBC)

Ms. Sebaugh reported on her attendance at the NDBC sponsored by the American Dental Association and noted that topics presented that would lend help in staffing the Dental Benefits Advisory Service Hotline were as follows:

AAO Member Hotline

- 9% of all calls relate to medical coding issues

- 15% of all calls relate to "other" issues
- 31% of all calls relate to reimbursement issues
- <1% of all calls relate to HIPAA issues

Ms. Sebaugh was requested to note call questions and responses in greater detail so that a possible question and

answer resource piece may be developed for use as a future member education tool.

AAO At-a-Glance Guide to CDT 2011-2012

Ms. Sebaugh presented the updated version of the AAO At-A-Glance Guide to CDT coding resource. The updated version will be re-posted on the AAO website.

Access to Care Craniofacial and Special Needs Task Force (CSN TF)

Ms. Sebaugh reported on the meeting of the Craniofacial and Special Needs Task Force and noted that one of the initiatives coming forth from the meeting would be that all AAO members participating in a craniofacial team will be listed on the AAO website.

AAO Donated Orthodontic Services (DOS) Program

Dr. Robirds reported that the AAO ATC Task Force had recently met via teleconference and provided the council with an overview of the status of the pilot programs.

Dr. Gayle Glenn noted that the AAO ATC Task Force recently requested additional program funding to underwrite more program coordinators' time. The additional time will help ensure that all orthodontists who have volunteered for the program will be provided with a case to treat.

COOP is responsible for providing resources to AAO members to facilitate their practice of our specialty. Below is a brief summary of some of the initiatives that benefit each and every member of our association.

COOP helps our members who are completing their orthodontic residencies or those who are new to practice. The AAO Practice Opportunity Service (POS), assists members in the transition from residency to practice. The AAO's Practice Opportunities Online connects AAO member SEEKERS searching for an associateship, partnership or a practice with PROVIDERS offering these practice opportunities. And, this is a free service. COOP helps our members by providing webinar presentations, which include topics including practice management themes such as Navigating Practice Finances, Risk Management for Staff, and Infection Control. This is a wonderful resource for residents and active members. Also, COOP is considering a makeover for the AAO Office Design Manual

section of the members website which can benefit all of our members.

COOP provides our active members with materials and programs to enrich their practices. This past February (2011) COOP organized and hosted the "Orthodontist as CEO" conference in San Diego. COOP provides several webinars each year, which are of great value to orthodontists and their staff. We have been asked to evaluate a suggested periodontal protocol for orthodontists to reduce the risk exposure we may have when treating adult patients. With the changing demographics of the population in both America and Canada, COOP is considering programs to improve the "cultural competence" of our members. On behalf of the AAO, COOP provides our communities with resources such as a comprehensive brochure for school nurses on "Handling Orthodontic Emergencies" which is distributed to thousands of school nurses across the country.

ABO Unveils Renovated Offices and New Examination Center

A ribbon cutting ceremony was held on November 17, 2010, to commemorate the ABO's renovated office space and newly constructed examination center. ABO directors, examiners and staff along with representatives from AAO, CDABO and others were in attendance to celebrate this historic event.

Following the ceremony, the first clinical exams in the new testing center took place November 18 – 20, 2010. The customized state-of-the-art examination center allows the ABO to administer all exams more effectively, efficiently and frequently. The examination center offers 10 exam rooms wired for sound and video recording to allow monitoring of the exam process. All rooms are equipped with 22-inch dual monitors to allow easy viewing of digital records. In addition, the newly renovated office

space offers a more convenient and comfortable working environment for the examiners, who devote up to 15 hours a day to the examination process. Conference rooms, a computer lab, a fully equipped kitchen, and lockers are accessible to the examiners.

Exams will be offered every February, June and November with a fourth examination possible in 2012. The February exam will continue to be offered in Dallas, Texas, for 2011 and 2012 due to contractual obligations. A trial complete electronic case submission (with the exception of post-treatment casts) will be conducted at the June 2011 examination. The ABO anticipates examining 800 to 1,000 orthodontists annually at the new facility. The examination center is located within the AAO headquarters building and is conveniently located near the St. Louis Lambert International Airport. The ABO looks forward to utilizing this site to its fullest potential and with its continuing partnership with the AAO. When not in use, the examination center will be available to other dental certifying boards interested in renting the facility.

The inaugural exam yielded 35 new or recertified Diplomates. Of the 220 cases presented, 202 were complete, which is a 92% completion rate. Initial Certification Examination (ICE) examinees that just completed their residency, banked over 20 cases and because they completed at least four cases with one case having a DI of at least 20, they are able to mail in the remaining category cases.

ABO Clinical Examination

The last ABO Clinical Examination was held February 19 – 23, 2011 with 179 examinees scheduled. The examiner orientation and training was held on Friday, February 18th, with calibration on Saturday, February 20th. Exams were held Sunday through Tuesday with examiner departure on Tuesday evening, February 22nd, or Wednesday morning, February 23rd.

ABO Written Examination

The 2011 ABO Written Examination will be conducted during the week of April 19 – 22 at Pearson-VUE Computer Centers across the United States and Canada. There are currently 340 examinees registered for the exam.

2011 Annual Session in Chicago, Illinois

The ABO Directors will arrive on Tuesday, May 10th, 2011 with board meetings on Thursday and Friday. The Emeriti Breakfast and Ketcham Reception will be held on Monday, May 16th. The ABO President's Dinner will be held on Tuesday evening, May 17th.

Registration is Open for Upcoming ABO Clinical Examinations

Many AAO members who have Diplomate status with the ABO must recertify by 2012. Upcoming Clinical Examinations for Recertification, Initial Certification (ICE) and Beginning Certification will be offered at the new ABO testing facility in St. Louis. Registration deadlines are: March 15th (for the June 16 – 19, 2011 Clinical Examination) and August 15th (for the November 17 – 20, 2011 Clinical Examination). AAOF Craniofacial Growth Collections

With AAOF support, nine of the eleven known collections of longitudinal craniofacial growth records in the U.S. And Canada have joined to create a Web site, www.aaoflegacycollection. org. The purpose is to make a representative sample of materials from the participating collections available for viewing and further investigation by clinicians, craniofacial investigators, students of human growth and interested members of the public.

These collections represent the work of hundreds of investigators and have been gathered, cataloged and studied over a period of more than seventy-five years, and the materials they contain are literally irreplaceable. Each of the collections is independent from the others and has pursued it's own sampling and data collection strategies. Available documentation of the growth process in the collections includes cephalometric films, hand-wrist films, dental radiographs, facial photographs and study casts as well as written records on the physical and educational development of children of varied ethnicities and growth patterns.



LEGACY 300

AAOPAC NEWS BY DR. RICK PFEFFER

The AAOPAC had another successful year in fund raising and supporting winning candidates. The AAOPAC raised slightly less than the previous year. The reasons for the slight downturn in donations could probably be explained by the economy. The AAOPAC and COGA met jointly in Washington, DC in conjunction with the Advocacy Conference. We were addressed by former Speaker Newt Gingrich and many Congressmen and Senators. The last day of the conference was devoted to Capitol Hill visits where we carried the message of the AAO to our legislators. To sum up the position of the AAO is to say that we are pro small business and pro profession.

In the 2010 election cycle, 24 of 27 (90%) candidates that the PAC supported in decided Senate races won their elections. Additionally, 62 of 76 (82%) candidates that the PAC supported in decided House races won their elections. Overall, the PAC enjoyed an 83% winning percentage across 102 Congressional candidates.

Additional information on the PAC's contributions:

- 18 of 23 (78%) Democrats the PAC supported in the 2010 election cycle won their races
 - o 3 of 3 (100%) in the Senate
 - o 15 of 20 (75%) in the House
- 68 of 80 (85%) Republicans the PAC supported in the election cycle won
 - o 21 of 24 (91%) in the Senate
 - o 47 of 56 (87%) in the House

The goal of our PAC is to raise a million dollars in a two year election cycle. We have hired a consultant, John Hancock, to help in this endeavor. We have also identified state liaisons who will be the point persons within each state. They are: Dr. Greg Oppenheizen, Michigan; Dr. Phil Beckwith, Ohio; Dr. Aaron Dellinger, Indiana, and Dr. Rick Pfeffer, Western Pennsylvania. We are starting to become an effective

lobbying force on Capitol Hill. We have definitely achieved some success and with a more pro business House of Representatives, I expect more success in the future, but we need your help. We have been successful in eliminating our profession from the Red Flag rules which would have required us to develop an identity protection program because we extend credit to our patients. We have been successful in adding our voice to the choir for the elimination of the 1099 requirement which would have meant anyone receiving over \$600.00 per year getting a 1099. This would have been a paperwork nightmare for our practices. We are also advocating raising the limit in Flexible Spending Accounts (new bill would lower it to \$2500.00 per year). Over 60% of our patients use these accounts to help pay for their orthodontic treatment.

Please consider contributing to the PAC at some level. We need to build relationships now, rather than later, because it is better to be at the table, than on the table.

Public Awareness Campaign - The OAO is currently waiting for a further update by the Schupp Corporation on the success of the OAO media campaign and how Schupp plan on increasing exposure of the OAO website on Google. Some members have expressed concerns regarding the value of engaging Schupp.

The Royal College of Dental Surgeons of Ontario (RCDSO) has indicated that it will lift the moratorium on CBCT by the end of 2011. Dentists, in Ontario,

can own the equipment but will have to take a special course to obtain a license along with an initial and annual fee.

The Ontario Dental Assistants Association (ODAA) is planning to establish its own college by 2013. You **must cooperate** if the College of Dental Hygienists of Ontario (CDHO) decides to audit your office, via your hygienists.

Bill 168, An Act to amend the Occupational Health and Safety Act (OSHA) with respect to violence and harassment in the workplace and other matters, came into effect June 15, 2010. Workplaces in Ontario with more than five workers are now required to have the necessary policies, programs, measures and procedures in place. The OAO Board is evaluating how it can best assist its membership with additional information to that already provided by the RCDSO in the Dispatch publications.

The National Dental Specialties Organization (NDSO) is currently in the process of being formed and will represent specialists to the Canadian Dental Association.

GLAO now has the OAO website link on the Components page. The OAO is working on a reciprocal arrangement.

There is Risk in Allowing Patients to Dictate Treatment

allowed the patient to dictate treatment resulted in litigation. It took two years to resolve and she settled for nearly \$25,000.

Case # 2: A 12-year old patient presented with a Class III malocclusion, undersized upper teeth and a diastema. Her Phase I treatment had been completed by another doctor. For Phase II, the second orthodontist recommended leaving spaces between the upper laterals and canines because of the mild tooth size discrepancy and the Class III growth pattern. He explained to the mother that overretracting the teeth would produce an under bite and potentially create TMJ problems. He recommended bonding after treatment was complete. The mother insisted that all upper spaces be closed. One year later, as the spaces closed, the patient began complaining of TMJ pain. The orthodontist recommended re-opening the anterior spaces to allow the mandible to reposture forward and relieve the posterior displacement of the mandibular condyles in the fossa. The mother finally agreed to the insured's treatment plan, the treatment was reversed and the patient's pain abated. She made a claim for inappropriate treatment.

Case # 3: The 18-year old patient had horizontally impacted maxillary canines overlaying the lateral incisor roots, causing resorption. Insured recommended extracting the canines and providing a bridge; the mother insisted the doctor continue to bring the canines into the arch. The orthodontist and an oral surgeon monitored the area of the impacted teeth carefully. Bone loss was a problem, and the necessary bone regeneration did not occur. The patient eventually lost 4-5 teeth

including laterals, bicuspids, and the impacted canines. The mother filed a lawsuit alleging negligent orthodontic treatment.

Why would an orthodontist choose to allow a patient or parent to dictate treatment? As one insured stated in his claim, "... he knew the patient's treatment request would not work but he complied 'just to show her'." When the outcome was unsuccessful, as he knew it would be, he was surprised that she filed a claim against him. Some doctors may be inclined to agree to the patient's wishes because they fear losing business. If this is your motivation, please reconsider. By not letting go of such business, you may be gaining a malpractice claim for a treatment that is likely to result in poor outcome, which today is support for a claim.

Planning and managing the treatment is the doctor's job, not the patient's. The orthodontist is the professional, with the education and experience. If your patient demands treatment with which you disagree, it should be declined. There is no defense if an ineffective treatment is performed. The damages in our claims range from minor bite problems which can easily be adjusted, to inappropriate loss of teeth, to allegations of serious TMJ pain. The fact that the patient demanded the treatment will not insulate the doctor from responsibility for the outcome. The law will hold the professional responsible, even if the patient dictated the treatment.
