#### **ABO News and Information**

### A Required Change to the ABO Scenario-based Clinical Examination

The ABO, like all organizations, has had to weigh options and identify adjustments that best allow them to accomplish their mission, serve orthodontists, and maintain the highest commitment to health and safety. The ABO board, staff, and consultants have been working diligently to identify every viable method of administering the Scenario-Based Oral Clinical Examination in light of so much uncertainty regarding the future of travel and inperson gatherings.

Therefore, in response to COVID restrictions and the safety requirements recommended by the CDC, the American Board of Orthodontics is making a change to the Scenario-Based Clinical Examination Instead, **all** Scenario Based Clinical Board Exams from now on, will be held at Scantron Testing Centers throughout the U.S. and Canada. Traveling to the ABO testing center in St. Louis **will no** longer be necessary. Thus, removing barriers that might have prevented the attainment of ABO certification.

This decision was made with serious deliberation and evaluation of multiple options. The goal was to find the best way to balance honoring commitments to exam candidates and maintaining the integrity of the exam, while protecting the health and safety of all involved in the examination administration.

#### **ABO Written Examination**

Due to COVID-19 concerns, our original testing centers offered limited appointment availability, directly impacting our Written Examination originally scheduled on April 7,

2020. Identifying an appropriate solution to this problem was our top priority as this examination is often used as an exit examination for many orthodontic programs.

In response, the examination was postponed to June 5th and 6th, 2020. The administration of the examination was modified to a Live Online Proctored Written Examination, overseen by Scantron and Examity.


