The American Board of Orthodontics (ABO) is proud to announce that 63% of the American Association of Orthodontists (AAO) are now board certified! Board certification continues to set the standard of care for the specialty. We are leading the way - together!

#### **Written Examination Update:**

The 2024 ABO Written Examination was administered to 443 examinees on April 2, at Pearson Vue Testing Centers in the United States and Canada. The examination had a <u>99% pass rate</u>.

#### **Scenario-based Clinical Examination Update:**

The ABO February 2024 Scenario-based Clinical Examination was conducted February 22-23 at Pearson-Vue Testing Centers Worldwide. A total of 329 orthodontists were certified during the 1<sup>st</sup> and 2<sup>nd</sup> Quarters of 2024, including the February examination, which had an <u>89% pass rate</u>. #### Future Examination Dates Announced

<u>Written Examination</u>: The 2025 Written Exam will be held on April 9, with online registration scheduled to open November 6, 2024. The exam will be administered at Pearson-Vue Centers in the United States and Canada. Applicants must have graduated or be currently enrolled in an advanced specialty education program in orthodontics and dentofacial orthopedics in the United States or Canada, accredited by CODA. Orthodontic residents must have completed 18 months of their program by the Written Examination date to be eligible to take the exam.

Scenario-based Clinical Examination: The next Clinical Examination will be administered September 17, 2024 (registration is now open through June 20, 2024 or until all slots have been filled). The examination will be held at Pearson-Vue Centers Worldwide. Beginning in 2025, the ABO will transition to one fall Scenario-based Clinical Examination per year.

#### **Certification Renewal Reminder**

ABO certification renewal is an important component of the board certification process. Successful completion of the examination is required every 10 years to maintain an active board certification status. Board-certified orthodontists are notified 3 years prior to the expiration date printed on their certificate that they are eligible to take the Certification Renewal Examination. You have two options to renew, including an Online Board Case Exam or a Mail-In Case Report Exam, along with completing continuing education credits from four online AJODO examinations. #### ABO Ambassador Pathway Program

The ABO has replaced the former ABO Advocacy Program with the Ambassador Pathway Program. This new program consists of in-person (or virtual) presentations by ABO Ambassadors, as requested by orthodontic programs, and will focus on the pathway to board certification and the value it contains both personally and professionally. 16 Ambassadors have been selected, representing all 8 constituencies. These individuals received training from ABO Directors and staff during the 2024 AAO Annual Session. The program's soft launch is scheduled for June 2024.
